



A mission is a portfolio of actions across disciplines intended to achieve a **bold and inspirational and measurable goal** within a set timeframe, with **impact** for society and policy making as well as relevance for a significant part of the European population and wide range of European citizens.

Horizon Europe defines mission characteristics and elements of governance, and 5 missions areas.

Specific missions will be programmed within the Global Challenges and European Industrial Competitiveness pillar (drawing on inputs from other pillars)

- **Conquering Cancer: Mission Possible**

Targets by 2030: more than 3 million more lives saved, living longer and better, achieve a thorough understanding of cancer, prevent what is preventable, optimise diagnosis and treatment, support the quality of life of all people exposed to cancer, and ensure equitable access to the above across Europe.

- **A Climate Resilient Europe - Prepare Europe for climate disruptions and accelerate the transformation to a climate resilient and just Europe by 2030**

Targets by 2030: prepare Europe to deal with climate disruptions, accelerate the transition to a healthy and prosperous future within safe planetary boundaries and scale up solutions for resilience that will trigger transformations in society.

- **Mission Starfish 2030: Restore our Ocean and Waters**

Targets by 2030: cleaning marine and fresh waters, restoring degraded ecosystems and habitats, decarbonising the blue economy in order to sustainably harness the essential goods and services they provide.

- **100 Climate-Neutral Cities by 2030 - by and for the citizens**

Targets by 2030: support, promote and showcase 100 European cities in their systemic transformation towards climate neutrality by 2030 and turn these cities into innovation hubs for all cities, benefiting quality of life and sustainability in Europe.

- **Caring for Soil is Caring for Life**

Targets by 2030: at least 75% of all soils in the EU are healthy for food, people, nature and climate. The proposed mission combines research and innovation, education and training, investments and the demonstration of good practices using “Living labs” (experiments and innovation in a laboratory on the ground) and “Lighthouses” (places to showcase good practices).





### Types of partnership

The aim of European partnerships with EU and associated countries, the private sector, foundations and other stakeholders is to deliver on global challenges and modernise industry.

The Horizon Europe proposal lays down the conditions and principles for establishing European Partnerships. There are 3 types:

#### Co-programmed European Partnerships

These are partnerships between the Commission and private and/or public partners. They are based on memoranda of understanding and/or contractual arrangements.

#### Co-funded European Partnerships using a programme co-fund action

Partnerships involving EU countries, with research funders and other public authorities at the core of the consortium.

#### Institutionalised European Partnerships

These are partnerships where the EU participates in research and innovation funding programmes that are undertaken by EU countries.

These partnerships require legislative proposals from the Commission and are based on a Council Regulation ([Article 187](#)) or a Decision by the European Parliament and Council ([Article 185](#)). They are implemented by dedicated structures created for that purpose.

Institutionalised partnerships will only be implemented where other parts of the Horizon Europe programme, including other types of partnership, would not achieve the desired objectives or expected impacts.

[EIT Knowledge and Innovation Communities](#) (KICs) are also institutionalised partnerships. EIT KICs aim to address skills shortages and are already established under Horizon 2020. Key partners in EIT KICs are higher education institutions, research organisations, companies and other stakeholders.




**Mandatory Open Access to publications:** beneficiaries shall ensure that they or the authors retain sufficient intellectual property rights to comply with open access requirements

# Accés Obert - As open as possible as closed as necessary



- **Immediate open access through trusted repository** (at the latest at the time of publication)
- **No opting out** of Research Data Management. Projects generating research data **MUST manage their data** responsibly and in line with FAIR principles
- **Exceptions to open access** (duly justified in the DMP; legitimate interests or constraints)

# Comitolo - What?

## Programme Committee:

- One committee per programme.
- Horizon committes are considered management committes.

3. Write a brief description in which you can identify: problem, objective/s, possible end-users and main outcomes.
4. Choose the type of action.
5. Impact related to the WP and Destination



# How to propose a topic:

- **Description of the topic (Specific challenge + Scope)**

- What is the problem? What do we want to solve?
- What has already been done? (On-going projects, EU Directives & policies, etc.)
- What do we propose to research or develop in this topic? (i.e. Knowledge, procedures, study, pilot, demonstration, tools, etc.)
- End-user who will give the requisites and will validate project results?



- **Expected Impact:**

- Impact on end-users.
- Impact on policies or EU Directives.
- Social impact.
- Impact at industrial level -> Sector competitiveness
- SME participation
  - **Possible funding scheme.**
  - **Background information:** previous projects, initiatives (at national or EU level), EU Communications, etc. -> This is not included in the text, but it helps a lot in the definition.

## Example: Horizon 2020

**BES-1-2015: Maritime Border Security topic 1: radar systems for the surveillance of coastal and pre-frontier areas and in support of search and rescue operations**

**Specific challenge:** Activities in the Mediterranean Sea related to border surveillance, including fight against drug trafficking and illegal immigration as well as search-and-rescue operations require for the authorities to detect at a long distance (typically: over the horizon) the presence of small vessels. The performance of existing radar systems need to be improved to that effect, or to be combined with other technologies. The cost and power requirements of such systems need to be lowered. Their deployment must also take into account the coastal environment, and they must integrate properly in the landscape. They should interface seamlessly with existing infrastructure supporting operations undertaken, or the services provided by the CISE constituent communities.

**Scope:** Pre-competitive research in areas ranging from sensor design, to the analysis and design of system configuration and integration and validation by (public) authorities for target detection, identification and recognition. Projects will focus only on border surveillance and search and rescue (not defence) needs.

**Expected impact:** To contribute to redress the limitations of current border surveillance systems at sea, particularly concerning the detection and tracking of small unseaworthy vessels. Impact will be benchmarked against improved capabilities to meet surveillance requirements in conditions ranging from those of the Southern Atlantic to the Greek archipelago. This topic would contribute further to the development of the European Border Surveillance System (EUROSUR) and the Common Information Sharing Environment (CISE) at sea. Technology provides extended coverage over the coastal marine band radars, potentially reaching pre frontier detection, thus proving appropriate for the main missions of EUROSUR45. For this reason research and innovation should focus at future seamless cooperation and interfacing with existing infrastructure supporting the CISE constituent communities. The appropriate participation of competent national authorities is necessary to better define needs.

**Type of action:** Research and innovation action. The output of the proposal is expected to lead to development of (a) prototype(s) up to Technology Readiness Level (TRL) 5; please see part G of the General Annexes.

**Indicative budget:** The Commission considers that proposals requesting a contribution from the EU of between €4m and €8m would allow this specific challenge to be addressed appropriately. Nonetheless, this does not preclude submission and selection of proposals requesting other amounts.



# Common mistakes:

- No European dimension/no European added value.
- The topic doesn't solve a EU or World problem, but a **national problem**.
- The proposed research **is not in the COM agenda** (no match objectives of the programme and Horizon Europe).
- The description (specific challenge + scope) of the topic **is not self-explanatory**.
- The proposed text is not **concrete** enough, it's not interesting for the **end-users**, it doesn't contribute to improving social issues, governance, etc...
- The topic is very much similar **to other funded activities**.
- The title is not “sexy”.
- The budget is not in line with the research.
- The topic involves problems at societal/ethical level.


